

PUBLISHING AGREEMENT

hereinafter referred to as the "Agreement", concluded on
between
residing in
hereinafter referred to as the "Author," and the Editorial Institution of the Wrocław Board of Scientific
Technical Societies Federation NOT, ul. Piłsudskiego 74, 50-020 Wrocław, represented by Editor-in-Chief
Professor Jerzy Jędrzejewski, hereinafter referred to as the " Publisher".

The parties hereby agree as follows:

§ 1 Copyright ownership

1. The Author declares to own copyrights (personal and material) to the article

hereinafter referred to as the "Work."

The title of the Work may be modified by mutual agreement.

2. The Author declares his copyrights to the Work are not limited within the scope of this agreement and that the Work does not affect in any way the rights of others.
3. The Author declares that he assumes responsibility for all claims of third parties against the Publisher arising from any infringement of third party rights to the Work.

§ 2 Transfer of rights

1. The Author transfers free of charge all material copyrights onto the Publisher to use the Work in all areas of exploitation specified in Art. 50 of the Act dated 4 February 1994 on Copyrights and Related Rights as well as the right of consent to the execution of dependent copyrights.
2. The transfer of copyrights to the Work includes the right to make any further dispositions of these rights, especially to transfer them whether in return for payment or free of charge onto third parties.

§ 3 Publication Ethics

§ 4 Rights and obligations of the parties

1. The Author is required to provide the Work to the Publishers in the electronic version in MS Word format, edited according to the received format.
2. The Author is obliged to ensure proofreading and consideration of reviewers' comments. If the Author fails within the prescribed period to carry out proofreading, this means that the Author approves of the form of the Work presented by the Publisher.
3. If the Author does not take reviewers comments into consideration within two weeks of their receipt, the Publisher reserves the right to withdraw from this agreement.
4. The Publisher undertakes to publish the work in the quarterly magazine "Journal of Machine Engineering" upon fulfillment of the requirements set by the Author in point. 1 - 3 of this paragraph and after the appropriate fee has been paid by the ordering party or the Author.

§ 5 Final Provisions
